The program also offers up to \$100,000 of Group Life insurance at the same low rates to as few as five enrollees, subject to evidence of insurability.**

For added protection and value, you can include our **Accidental Death and Dismemberment (AD&D)** option. The insurance amount is equal to the Voluntary Life benefits the employees select for themselves and their covered spouses. AD&D benefit is selected at the group level.

EMPLOYEE ELIGIBILITY Employees meeting all of the following requirements are eligible for coverage:

- 30 days of continuous service with the employer.
- Full-time employment (i.e., working 30 or more hours per week).
- Work 15 of the 20 working days prior to the effective date of coverage.
- Actively at work on the effective date of coverage.

GUARANTEED ISSUE SCHEDULE Guaranteed Issue is based on participation levels and the number of employees eligible to participate at the time of enrollment. All coverage for children is Guaranteed Issue. Guaranteed Issue is not available for individuals age 65 or older. Minimum participation for Guaranteed Issue is 25%, but not less than 10 lives.
